On July 10th, we had a National Association of Canine Scent Work (https://www.nacsw.net/) Odor Recognition Trial (ORT) at the Kindred in Sequim, Washington. Miriam Rose was our judge. Miriam is also the owner of The Kindred Training Center. Club member Georgia Edwards was our Certifying Official. (Georgia donated her fees as Certifying Official to the Club.)

Passing the ORT is a prerequisite for scent work trialing with the NACSW. All dogs have to prove that they can identify and indicate the three odors used in competition: Birch, Clove, and Anise. This is frequently the first organized dog event that dogs and their handlers attend. We had 26 dogs entered and ran 67 individual tests. (Most dogs tested on all three odors. Though a few were tested on only one or two odors. Making up for missed odors in previous tests.)

The weather was good - a bit warm but tolerable. At least for those outside. Those of us who were in the test building all day got a little overheated, but it never got too hot for the dogs to work.

We netted \$1445.97 for the trial. Making this a nice fund raiser for the Club and a great service to the scent work community.
